10/ Procedure details:

Why we need this strictly procedure:

Due to many frauds we need to change strictly our procedure and rules to protect our credibility and Client's.
If the Buyer or Representative cannot accept this procedure, properly it means he is not a real buyer.

Please note: Our Clients have to sign MOU. If the Buyer not continue within 1 week to close the deal, a consulting fee of 500 USD has to be payed as a penalty. Furthermore, we will not connect genius seller's and buyer's, until both company registration has not been verified.

Procedure: **Please note: Cranberry and Cardinal only work upfront with LOI / ICPO / LOA / FCO / POF A2A**

1. BUYER send LOI and SELLER will provide NCNDA and IMFPA to the intermediaries. Please note: Some Sellers they expect LOI, ICPO and LOA.
2. Both parties sign MOU for the credibility of both parties
3. Seller provide FCO to advice the Buyer to enter in the final SPA. Please note: Some SELLER'S only provide FCO after LOI, ICPO and LOA.
4. BUYER sign the FCO within 1 day for acceptance and returns it to the SELLER
5. Within max 1 days the BUYER provides his POF Bank to Bank or Attorney to Attorney some kind of bank statement or BCL
6. SELLER, BUYER, FACTORY and the logistic company enter the negotiation for details of the SPA
7. SELLER, BUYER, FACTORY and the logistic company confirm the details and sign the SPA
 - After verification of the POF, the SELLER will send POL live stock video or SGS report or a video from inside the factory/warehouse
 - SELLER will share documentation of business relationship of SELLER and FACTORY
 - The Chamber of commerce confirms the business relationship of all Parties and export quota for BUYER
 - The FACTORY and the logistic company will provide the delivery schedule to the BUYER.
8. After signed SPA, the BUYER shall open his own account in Vietnam or open his payment instruments L/C or Escrow or MT103 blocked funds direct to the SELLER
9. Upon of the confirmation of the BUYER'S own account in Vietnam or his payment instruments L/C or Escrow or MT103 blocked funds to the SELLER, the BUYER shall release the down payment to the FACTORY and the FACTORY will start the production and send the goods to his port of origin or in case of CIF to the BUYER'S nominated destination, regarding the delivery schedule. In case of available stock, the SELLER will send the goods regarding delivery schedule to the Sellers port of origin or in case of CIF to the BUYER'S nominated destination.
10. After BUYER receive the goods at the SELLER'S port of origin or his nominated destination, the BUYER shall confirm the delivery of the goods and release the remaining funds to the SELLER and take over the responsibility of the goods
